6. Brief Report

To the best interest and continuous journey of creation and innovation at Symbiosis International (Deemed University) a Workshop on "Intellectual Property Awareness" for faculty of Symbiosis Centre for Information Technology (SCIT) was conducted on Tuesday, 2.04.2024 by resource persons **Dr. Amol Sapatnekar and Dr. Shraddha Damle**, from 2.00 pm to 3.30 pm.

The objective was to sensitise the faculty members of SCIT towards Intellectual Property (IP). During the workshop Dr. Amol presented a foundational understanding of IP, including patents, copyrights, trademarks, Trade Names & Services Marks, Geographical Indications, Industrial Designs, Layout-designs of Integrated Circuits, Trade Secrets and Copyrights and Related Rights. The focus was on filing patents and the legal framework surrounding them. He discussed how a planned strategy is required for the incremental innovation. A patent is granted to a patentable subject matter if it satisfies the three prerequisites of novelty, utility and inventive step also the about the economies and TRIPS and also legal process to follow post TRIPS.

Dr. Shraddha Damle spoke about Blockchain technology, NFTs, and digital art which offers innovative ways to address longstanding issues in IP law, such as proving originality and authenticity, managing copyright and licensing, and combating counterfeiting and piracy.
